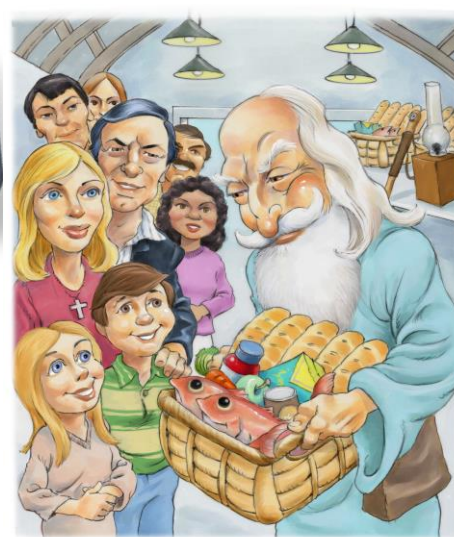

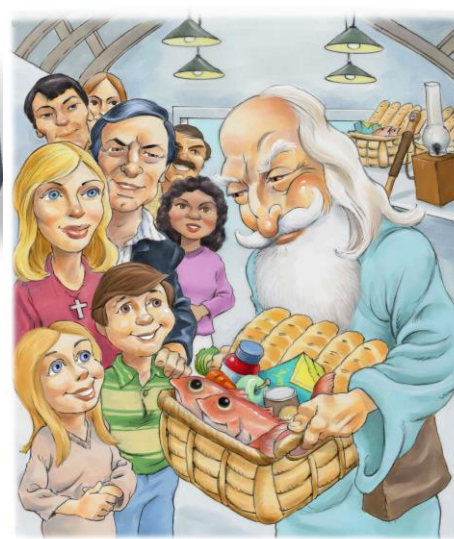

Food Sources

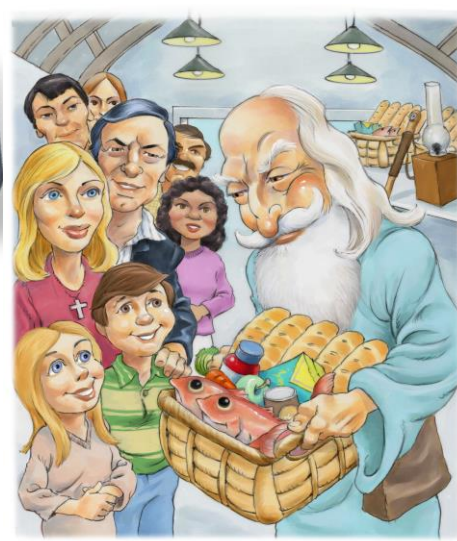
Through this support mechanism of financial contributions, each church food pantry (who knows their own needs best) must procure food resources through local providers, i.e., grocery stores and farmers.

Zone 8 = Colorado, Montana, North Dakota, South Dakota, Utah and Wyoming

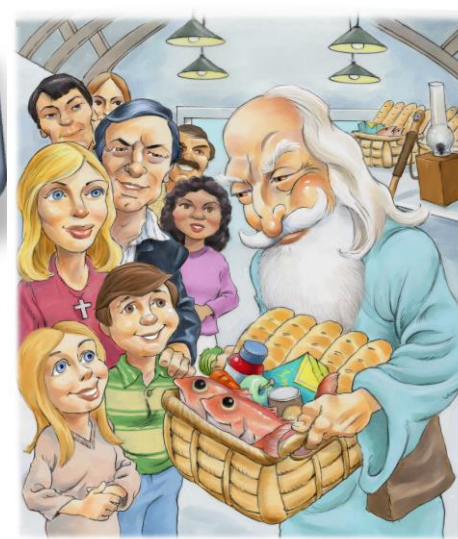
Zone 9 = Alaska, Idaho, Oregon and Washington

SECTION 2

FAM/501C3 PARTNERSHIP REQUIREMENTS

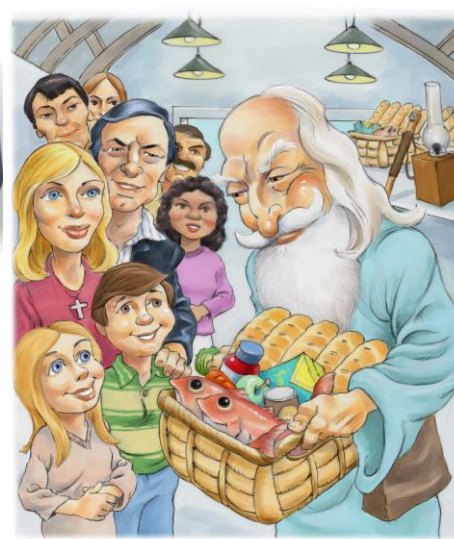
To be considered for participation as a program partner, the Food Pantry must have qualified under Section 501(c)(3) of the Internal Revenue Code as a tax-exempt organization. Full Armor Ministries agrees and complies with these guidelines.

1. Feed the needy, the ill, or infants (infants defined as all children under 18).
2. 5Loves2Fish will not be supportive to any Food pantry knowingly engaging in discrimination in the provision of service against any person because of race, color, citizenship, religion, sex, national origin, ancestry, age, marital status, disability, sexual orientation including gender identity, unfavorable discharge from the military or status as a protected veteran.
3. According to Food pantry standards, they can receive, store, and distribute food safely and efficiently.
4. Conform to the guidelines set forth by the Board of Directors of the FAM to maintain partnership status.
5. Use Food Pantry product only in a manner related to its exempt purpose and solely for the feeding of people in need stated by the partnership application.
6. Notify FAM of any changes in your programs' personnel, addresses, contact phone numbers, or email addresses.

Each year the list is re-evaluated. Additional openings for pantries to join may become available. Any violation of any of the policies listed in this policy guide may result in member suspension or termination.

Full Armor Ministries reserve the option to request a determination letter from the IRS verifying your qualifications.

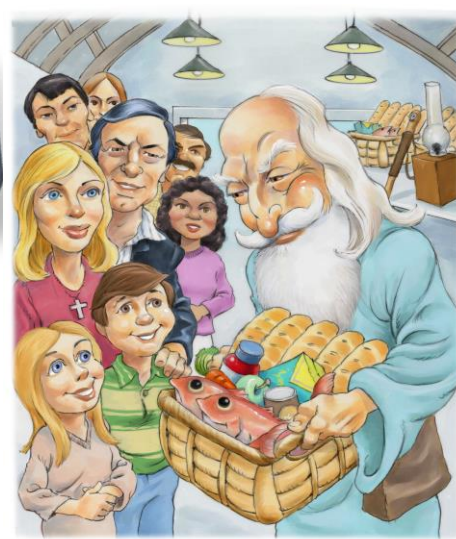
UNAUTHORIZED USE OF Full Armor Ministries Year-End Donation

Full Armor Ministries' year-end donation is for the sole purpose of feeding those in need. Using FAM donations in an unauthorized manner will result in the suspension or termination of FAM donation qualifications.

1. Food Pantries may not use FAM Donations for any church/religious functions, including but not limited to church dinners, Sunday school classes, or vacation Bible schools.
2. The Food Pantry's program staff may not use FAM Donations unless the following conditions are met:
 - a. FAM Year-end Donations may not be used for fundraising either as prepared food (such as spaghetti dinners or bake sales) or as "prizes."
3. If receiving financial support from the Full Armor Ministries 5 Loaves 2 Fish program, you should only use the funds for the following and provide receipts to remain in good standing with us.
 - a. Purchase food from local resources
 - b. Purchase shelving
 - c. Purchase or repair refrigeration
 - d. Purchase supplies

If Full Armor Ministries receives repeated adverse reports concerning the food pantry and the receipt of food or other items, FAM may be required to refrain from donating to the pantry.

COMMUNICATING CHANGES IN PROGRAMS OR PERSONNEL

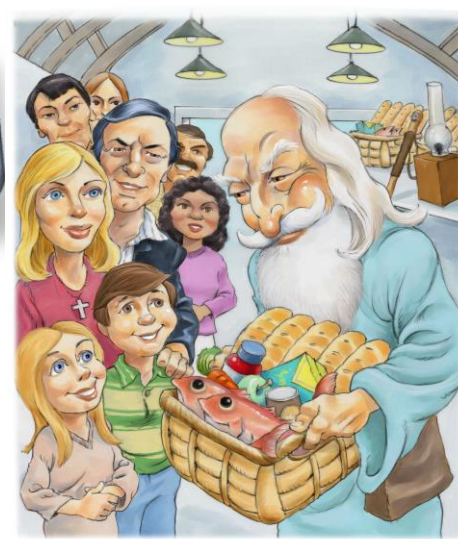
1. Please notify FAM of any operational changes in your Program that may affect the food pantry's operation ability. Please inform FAM concerning address, phone number, and e-mail address changes. Maintaining this information allows FAM to reach food pantry contacts and to mail newsletters and other important information.
2. The food pantry director, program coordinator, or religious organization leadership (pastor, rabbi, etc.) should submit any changes in writing on agency letterhead.

SECTION 5

AMENDMENTS/REVISIONS TO THE POLICY MANUAL

Full Armor Ministries reserves the exclusive right to modify this manual as deemed necessary without advance notice to food pantry partners. After receipt of any amendments/revisions, a food pantry may withdraw its membership within thirty (30) days. After that, it will be subject to amendments/revisions.





SECTION 6

Participation in this Pilot program 2021

Our mission is focusing our efforts to help those in need by implementing the 5 Loaves 2 Fish pilot program in the year 2021. We will be contacting 250 randomly selected independently operated church food pantries within the United States to join the program. Participation is optional and entirely free of charge.

In the 2021 distribution which will be distributed in 2022, the **Pilot Program** will have a starting total amount of \$1250.00 to be dispersed equally in \$50.00 increment as a guaranteed distribution to the first qualifying 25 submitted entries with 2-3 pantries chosen from each zone on the map.

Waiting List

In the event you are not one of the first 25 qualifying entries, which is first come first serve, your pantry will be placed onto the waiting list for the following year. Each subsequent year starts at a zero balance and the distribution amount begins again.

How to come off the waiting list and begin receiving program distribution.

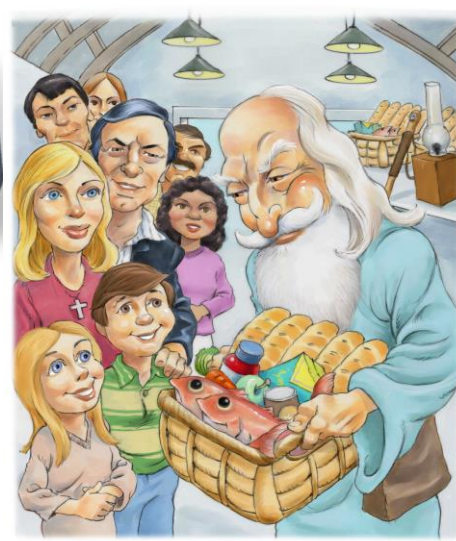
As our program receives additional funding either through donations or One Path Marketplace sales, and the distribution amounts increase we'll be able to add pantries from the waiting list into the program.

Here is an example for you: (the date and amounts are only for referencing the example)

We have a beginning donation amount of \$1250, providing each of the 25 pantries a guaranteed \$50.00 donation. If we receive an additional \$1250.00 from donations and an additional \$1250 from product sales, our final end of year amount for distribution now becomes \$3750.00. That will provide an equal distribution for that year to each pantry to be \$101.35.

With the 25 Pantries already in the program, this allows their donation amount to double while also allowing 12 additional pantries to join the program from the waiting list. Each year our target donation drive will be to double the prior years' distribution as a starting point the help ensure the pantries in the program do not take a distribution reduction and assist those on the waiting list the opportunity to join the program.





Fill out the entry form and ensure the pantry meets specific requirements of the program. Please read carefully all requirements listed in this policy guide and proceed to the entry form. Once accepted into the program, the policy guidelines must continue to be followed to prevent possible removal or ineligibility for the annual distribution.

The amount of financial donation will be determined at the end of Full Armor Ministries' fiscal year ending December 31st. The allocation of these funds will then be distributed via check, in February following the fiscal year-end accounting.

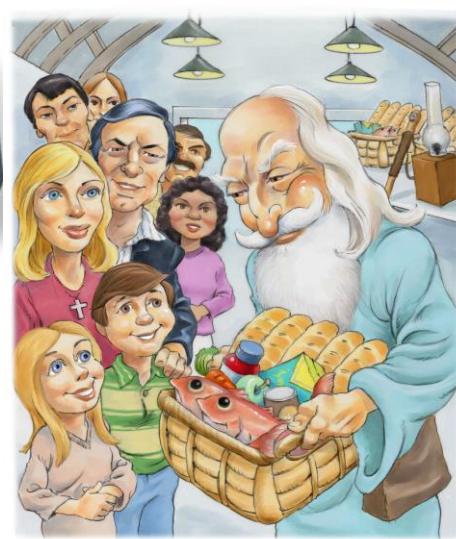
All profits generated come from "One Path Marketplace," online store or through direct donations received by Full Armor Ministries.

please opt out for that year to help provide a more generous payout for the other program partners.
